PERTINENT REQUIREMENTS

- Section 5.36 of the City Code, Licensing of Solid, Recyclable and/or Yard Waste, shall apply to all placements of Roll off Containers, or dumpsters, authorized by this Permit Application.
- Section 6.03 of the City Code, Right-of-Way Permits, shall apply to all work authorized by this Permit Application.
- An **Application Fee** must be submitted with the application. If application is paid by check, The City of Eden Prairie will present the check for payment to your bank electronically. Your original check will be destroyed once processed and you will not receive your cancelled check back.
- A sketch showing the location and work to be done must be attached to this Permit Application.
- Obstructions are to be placed within private property boundaries whenever feasible. Inspection of the site by City staff for feasibility of placement of the obstructions off public property or city streets will be required prior to authorization of placement of obstructions, including roll-off containers, equipment placement or other obstructions.
- Detour routing shall require 72 hours advance notice to the City Engineering Department.
- Flags, flares, signs, cones and/or barricades shall be erected to protect traffic and persons at all times, day and night.
- No guys or stays are to be attached to any trees.
- Streets may not be closed to traffic unless expressly authorized by this permit.
- Permits or copies of said permits shall be kept on the job site at all times and shall be exhibited upon request.
- Applicant must protect all existing utility installations.
- Within 24 hours of completion of the work authorized in this permit, the permit holder must notify the City that said work is completed and the site is ready for final inspection.
- Applicant must keep public streets free of mud, water, loose dirt, dust, etc. to the satisfaction of the City. Pictures of the area prior to placement of the obstruction recommended.
- Obstructions and/or roll off containers must be adequately enclosed or covered to prevent deposit of materials including, but not limited to, nails, dirt, glass, cans, discarded cloth, metal scraps, garbage, leaves, grass, tree limbs, paper products, shreds, rubbish, oil, or other petroleum products into any street.

AUTHORIZATION OF PERMIT

In consideration of the agreement to comply in all respects with regulations of the City of Eden Prairie, MN covering such operations, permission is hereby granted for the work to be done as described in the above application, said work to be done in accordance with special precautions as stated in City Code, including Sections 5.36 and 6.03. It is expressly understood that this permit is conditioned on replacement or restoration of the work site to its original or better conditions. It is further understood that this permit is issued subject to the approval of authorities having joint supervision over said street or easement.
