## Officer's Reports:

President: It was announced that Clifton, Larson, Allen will continue as our auditor in 2020.

Vice President: No report

Secretary: In the next 120 days Mark Salo (10 years) and Philip Skeie (11 years) become eligible for retirement benefits. Sidekick completed the record retention and safe storage digitization project and have returned our files and a hard drive on which is stored EPFRA records that are required to be retained by statute.

A summary of the Volunteer Fire Relief Association Working Group relevant to the EPFRA was provided. It was recommended that the period of time for appeal following Fire Chief annual service credit be shortened from 60 days to 21 days.

## Treasurer:

A motion to pay the invoice of \$2478.31 from Sidekick for the digitization project was made by Ms. Bassett. Mr. Hayden seconded the motion. The motion was approved by unanimous voice vote.
