Ms. Kotchevar reported that a new audit firm has been selected by the City of Eden Prairie. BerganKDV will be providing audit services to the City of Eden Prairie with an annual cost to the EPFRA of \$8400.00 for the yearly audit and completion of reporting forms required by the OSA. A motion was made by Ms. Nelson to utilize BerganKDV as our auditor as long as the cost does not exceed \$8400.00/year. Ms. Bassett seconded the motion which was then passed by the board on a unanimous voice vote.

President O'Brien discussed an audit plan for 2020 that would break out the various duties more evenly between the responsible parties on the board. The President, Secretary, and Treasurer will meet prior to the start of the 2020 audit to discuss and assign duties and timelines.

A motion to adjourn the meeting was made by Ms. Bassett. Ms. Nelson seconded the motion. The meeting was adjourned by unanimous consent at 6:05 PM.
