Brick and Bourbon, Hi-Five Sports and Starkey Remodeling

Brick and Bourbon has

been issued an interior finish permit for their new restaurant located in the retail space of Elevate at Southwest Station, 12900 Technology Drive. The new 6,240 square foot restaurant features a 950 square foot mezzanine, a bar, dining area along with a 2,111 square foot exterior patio. Unique features include a fire feature at the perimeter of the patio with adjacent seating and openable overhead doors at the dining area to permit the outside in. Brick and Bourbon is an elevated eatery and craft bar that believes in using only the freshest domestic and imported ingredients. There bar features one-ofa-kind craft cocktails that that focus on fresh and simple ingredients, which complement their amazing selection of spirits, they also serve craft beers and locally recognized and noteworthy wines.

Hi-Five Sports has received an interior finish shell permit for their new facility located on the lower level of the Eden Prairie Center into what was formerly the Scheels store. When the nearly 19,000 square foot space is completed it will include a future turf field, multiple basketball courts, golf area, party room along with a sizeable open area and reception room. Hi-Five's mission is "to enrich the lives of children through team sports in a fun and non-intimidating manner." They have up to twelve different team sports every week. Their experienced coaching staff divides the participants into balanced teams that learn about and compete in a wide variety of team sports. Hi-Fives's vision is to help the next generation develop a passion for sports - one camp, one coach and one child at a time. The company has been in business for over 30 years.

Replenex has obtained a remodeling permit for their facility located at 9815 74th Street West, The project is the result of downsizing of their space and includes tenant space modifications and improvements to their existing space.

Starkey has received a remodeling permit for a \$615,000 project at their facility located at 6425 Flying Cloud Drive. The project entails modifications to sales offices, the lobby/reception area, the beverage bar and new floor coverings and finishes.

Cub Foods located at 8015 Den Road was issued a permit to remodel their exterior facade and cladding. The project entails removal of the existing EIFS system and replaces it with an architectural wall paneling and new signage.
