## **Unfinished Business:**

Report on the EPFD fundraising effort was presented. In the first week approximately \$24,000 has been raised. Initial start up costs were about \$15,000.00 Recommended changes to expedite mailing 18,500 letters and making an electronic pay option easier to find and use.

## **New Business:**

Discussed the raffle drawing from the EPFD fundraising effort to be conducted at the City Wide Open House on October 9, 2021. Prizes of \$500.00, \$300.00, and \$200.00 to be awarded by drawing names from everyone who made donations related to the fundraising letter.

The Request for Proposal (RFP) selection process for a new investment advisor was discussed. Five firms will be interviewed beginning the week of October 11th with interviews completed before the October 28, 2021 EPFRA Board of Trustees meeting where an investment advisor will be chosen by the Board. The five firms to be interviewed are Northwest Mutual, Wells Fargo Parr McKnight, Wells Fargo CBS (our current investment advisor), Marquette Wealth Management, Bell Institutional Investment Management. President O.Brien will set up the calendar and provide to each Board member the schedule and documentation submitted by each firm before the interview process begins.

A motion to adjourn the meeting was made by Ms. Bassett and seconded by Mr. Hytjan. The meeting was adjourned without objection at 6:05 PM.
