The Office of the State Auditor Volunteer Firefighter Relief Association Working Group wrapped up its work for the 2022 legislative session on December 14, 2021 recommending modification of maximum allowable pension benefit levels, clarifying reimbursement of supplemental retirement benefits to allow multiple payments to a payee, authorizing distributions to alternate payees under a qualified domestic relations order, and requiring documentation of a certified fire service credit calculation to a firefighter if requested.

The Training Division of the Eden Prairie Fire Department (EPFD) presented a proposal for a firefighter engagement opportunity in the first quarter of 2022 in the amount of up to \$3,500.00 to be paid from the 2022 Not To Exceed Budget (General Account). A motion to approve the request from the EPFD Training Division for funds was made by Ms. Bassett. Mr. Hytjan seconded the motion. The motion was approved by unanimous consent. The EPFD will be increasing the size of the fire department from 95 to 99 members in 2022.

A motion to adjourn the meeting was made by Mr. Wilson. Mr. Gerber seconded the motion. The meeting was adjourned by unanimous consent at 6:20 PM.
