Regular Board of Trustees Meeting December 15, 2022

President O'Brien called the regular meeting of the Eden Prairie Firefighter Relief Association (EPFRA) Board of Trustees to order at 5:32 PM.

The minutes of the November 17, 2022 EPFRA Board of Trustees meeting were reviewed. A motion to approve the minutes was made by Mr. Casper. Mr. Dahlke seconded the motion. The motion was approved by unanimous consent. The minutes of the December 8, 2022 Special Meeting of the membership of the EPFRA were read. Mr. Casper made a motion to approve the minutes from the special meeting. Mr. Sykes seconded the motion. The minutes were approved by unanimous voice vote.

Officer's Reports:

President: There were four participants in the Investment 101 virtual class presented by Wells Fargo on November 29, 2022. Tentative plans virtual classes to be held in Quarter One, two, and four in 2023.

Vice President: No report

Secretary: Received Jeff Eggert's completed application for retirement benefits to be paid after January 26, 2023. Office of the State Auditor (OSA) Supplemental Aid Working Group completed its work on December 12, 2022. Twelve different alternatives will be forwarded to the Legislative Commision on Pensions and Retirement with no recommendations. The OSA Volunteer Firefighter Relief Association Working Group continues to meet. OSA recommended waiting to approve the Investment Report Card, for year ending December 31, 2021, to be provided by the OSA in early 2023 rather than approving the the last report card issued by the OSA for the year ending December 31, 2020. The working group approved language, to be included in the 2023 Pension Bill, allowing the relief association Board to certify the most recent OSA Investment Report and indicate this on the FIRE form signed by an officer of the Board and submitted to the OSA each year.
