# **Eden Prairie Firefighter Relief Association**

Regular Board of Trustees Meeting October 26, 2023

## **Investment Committee:**

Wells Fargo presented the third quarter 2023 investment report and investment outlook. The portfolio value as of September 30, 2023 was \$20,840,400 and is 103 percent funded. Allocations as of 9/30/23 as follows:

Return on investment (net of fees) was -3.11 percent for the third quarter and 4.06 percent year-to-date. Despite greater than expected growth in the economy this year there will likely be a recession in the first quarter of 2024.
