## **Investment Committee**

Reviewed the report from Wells Fargo regarding second quarter 2024 investment results. As of June 30, 2024 the value of our investment portfolio was \$23,154,005.00. Mr. Sykes recommended keeping real assets underfunded (currently 6.13 percent below the target allocation of 10 percent because of this asset class's relatively high fee structure of 1.25 percent.
