

2016 Annual Report

Dear Mayor Tyra-Lukens and City Council Members:

I am pleased to submit the 2016 Eden Prairie Police Department Annual Report to you and the residents of Eden Prairie. This report contains a summary of the events and operations the Police Department undertook in 2016.

Last year we experienced a number of staffing changes with the retirement of Chief Rob Reynolds at the end of June. On July 1, I was honored to become this department's sixth police chief. Subsequently, Greg Weber was appointed to Captain, Dave Becker was promoted to Lieutenant and Jess Irmiter became the department's newest sergeant.

In addition to Chief Reynolds' retirement, four other officers retired. As a result, we hired six new officers in 2016, five of whom had worked as Community Service Officers for the EPPD before being hired as officers.

Our calls for service were up slightly from 2015. We handled 50,744 calls in 2016 compared to 49,921 calls in 2015. The number of narcotics charges increased as officers are being trained on drug interdiction, particularly during traffic stops.

I am happy to report there were no traffic fatalities in 2016. There were however, four homicides in our community last year. After extensive investigations by our detectives, arrests have been made in all cases.

A more detailed table of 2016 statistics can be found on page 22 of this report.

2016 was the first year for the EPPD's 2016-18 initiatives. We have made great strides on many of them including Human Trafficking, License Plate Readers, Enhancing Healthy Living and Renovating the Mobile Command Center.

This year we plan to continue to work on the remaining initiatives including the establishment of a Street Crimes Unit, research on body cameras, re-establishing the Traffic Unit and adding an officer to the Joint Terrorism Task Force.

On behalf of the nearly 150 staff and volunteer members of the Police Department, I thank you for your continued support and look forward to serving you in the coming year.

Patrol Division



Lt. Dave Becker was promoted to lieutenant of the **Patrol Division** in August 2016. The Patrol Division includes eight sergeants and 38 officers. There are eight Patrol Units as well as the secondary Airport Unit, Crime Prevention, Domestic Abuse Response Team (DART), Field Training, K-9, Reserve, Retail Crime and SWAT units.

Sgt. Jess Irmiter was promoted to sergeant in September 2016. Sgt. Irmiter has worked for the department since 2001 as a patrol officer, investigator, K-9 officer, instructor, SWAT team member, Reserve Unit coordinator and Airport Unit liaison.





Officers Chad Streiff and Todd Groves were named to the Minnesota DWI All-Star Team by the Minnesota Department of Public Safety for achieving two of the highest number of DWI arrests in Minnesota in 2015. Officer Streiff made 49 DWI arrests and Officer Groves had 45 that year.

Officer Streiff also joined Officer Groves as a certified Drug Recognition Evaluator (DRE) last year. A DRE is an officer who has received specialized training on detecting and removing drug-impaired drivers from the road.

Six new officers were hired in 2016: Karl Knutson, Leslie Perez, Brett Lindeman, Matthew Rosati, Mason Heine and Evan Hynek. Although they were hired at different times throughout the year, they all took the ceremonial oath of office together, alongside their family members.

Investigations Division

The **Investigations Division** is led by **Lt. Jim Morrow**. This division consists of the Criminal Investigations, School Liaison and Special Investigations units. There are two sergeants, 13 officers and two full-time civilian employees in the Investigations Division.

At the department's Annual Awards and Recognition Program in November, **Detective Andy Rohde** was awarded the department's Officer of the Year Award for his thorough investigation of several major fraud cases in the previous year and his patience and tenaciousness while serving as an interviewer in human trafficking cases.

Analyst Ryan Kapaun received the Civilian Employee of the Year **Award** for his outstanding analytical support to the department, and in particular his work on last year's homicides. Earlier in 2016, Analyst Kapaun was named the Minnesota Analyst of the Year by the Minnesota Association of Criminal Intelligence Analysts and received the **2015 Tri-County Analyst of the Year** from the Tri-County Law Enforcement Association.

Investigations Division



The entire Investigations Division received a Unit Citation for their work investigating five homicides that occurred in Eden Prairie during a 10-month period from September 2015 to July 2016. Two of the cases were heroin overdoses in which the dealer was later charged with homicide.

EPPD detectives investigated three additional heroin overdose deaths in other communities that were linked to the same dealer. The dealer has been charged with five cases of 3rd-degree murder.

Two of the other Eden Prairie homicides occurred in May when a man killed his 23-year-old wife and their unborn child in their home. The man recently reached a plea agreement for 65 years in prison.

The fifth homicide occurred in July 2016 when a 74-year-old man was found dead in his home. After an extensive investigation which led investigators to Utah and back to Minnesota, a man was arrested and charged with 2nd-degree murder in the case.

Chief DeMann noted the division's teamwork, dedication and commitment in solving all of these difficult crimes.

Detective Carter Staaf received the City of Eden Prairie's Scott H. Neal Excellence in Leadership Award for his work in creating and leading a program to combat human trafficking.

In 2016 the EPPD conducted four human trafficking stings in Eden Prairie and arrested 27 people. The department also assisted neighboring agencies with stings in their communities.



Last summer the EPPD held a six-week Senior Citizens Academy where participants had a chance to learn about various aspects of the EPPD, including investigations, use of force, SWAT team, K-9, Dispatch, Crime Tech Unit and crisis negotiations. The Senior Citizens Academy is sponsored by the Eden Prairie Lionesses and the Eden Prairie Crime Prevention Fund.

and 24 civilians in the Support Division.



In 2016 the Support Division:

- Answered 50,744 calls for service in the Dispatch Center
- Processed 84 liquor license applications
- Processed 512 gun permit applications
- Processed 18,240 pieces of evidence
- Performed 322 fingerprint services
- Responded to 849 city ordinance violation calls
- Processed 10,177 records
- Processed 129 solicitor applications

Eden Prairie Police Department Reserves are adult volunteers who assist sworn officers by performing community service tasks and non-criminal police functions. Reserve officers also assist in natural disasters and other emergencies that require additional personnel. In addition, they help clean up Hwy. 5, serve as the City's Color Guard and are trained to provide basic emergency medical care.


Explorers

Explorers are young people ages 14-21 who are interested in law enforcement. Last year the Edina/Eden Prairie Explorers attended one national and two state conferences where they took home awards in multiple events including first place honors for Taser, Domestic Crisis and Hostage Negotiations competitions. Explorer Katie Kline, who is also a part-time EPPD Community Service Officer, placed first in the statewide police exam and Explorer Alex Geiger won the nationwide female individual fitness challenge.









Chaplains



The department's volunteer Chaplains provide emotional and spiritual care to community members and public safety responders. Chaplains take turns wearing a paging device and being on-call for the Department. In 2016 they were called out 22 times. The Eden Prairie **Crime Prevention Fund sponsors the** Chaplain program.

Two new chaplains joined the Chaplain Unit in 2016: Peter Johnson of St. **Andrew Lutheran** Church and Nolana **Holloway** of Live Your Beautiful Life Ministries.







In September the EPPD lost a cherished member of our family with the passing of Father Tim Power. Father Tim was a faithful servant to the residents of Eden Prairie in many ways, including serving as a Chaplain for the Eden Prairie Police and Fire Departments. Father Tim was one of the original Chaplains when the program started in 1992. In addition, Father Tim served on the Eden Prairie Crime Prevention Fund board for more than a decade. We will deeply miss the ministry of presence he provided to the community and our department.
